WHEREAS, on August 3, 2017, the Wayne Township Board of Education adopted a Resolution Invoking the Doctrine of Necessity, based upon conflicts involving five board members, to enable the Wayne Township Board of Education to consider and act upon the final agreement with the Wayne Education Association; and

WHEREAS, representatives of the Wayne Township Board of Education and representatives of the Wayne Education Association have reached a tentative settlement of a Memorandum of Agreement and Salary Guides which have been ratified by the Wayne Education Association; and

WHEREAS, the Wayne Township Board of Education intends to act upon the Memorandum of Agreement and Salary Guides with the Wayne Education Association at the August 10, 2017 Board Meeting.

NOW, THEREFORE, BE IT RESOLVED, that the Wayne Township Board of Education approves and ratifies the Memorandum of Agreement, Amendment to the Memorandum of Agreement, Salary Guides and Collective Negotiations Agreement dated July 1, 2017 through June 30, 2018; and authorizes the President of the Board of Education to execute the new Collective Negotiations Agreement reflecting this Memorandum of Agreement, Amendment to the Memorandum of Agreement, and Salary Guides as per attached by reference.
